### SPECIAL WASTE accepted with prior approval from NWNMRSWA:

- Sludge
- Petroleum contaminated Soil
- Special waste otherwise not specified.

#### UNAUTHORIZED WASTE

- All Hazardous waste
- ASH (Household ash only)
- Asbestos containing materials.
- Infectious Waste (Medical Red Bag)
- PCB's contaminated soil
- Any waste containing free liquids (paint, hand sanitizer, water, etc.)
- Anti-freeze

Although we have tried our best to screen all loads of waste, it would be helpful if you helped in your part when loading waste for disposal at our facilities.
